

Terms and Conditions

Agreement between User and Fortheloveofpods, LLC

Welcome to the Hubl podcast app (“Hubl”), a mobile application owned and operated by Fortheloveofpods, LLC. The Hubl mobile application (“the App” or “the Site”) is comprised of various web pages operated by Fortheloveofpods LLC (“FTLOP”). Hubl is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the “Terms”). Your use of Hubl constitutes your agreement to all such Terms. Please read these terms carefully, and keep a copy of them for your reference.

Hubl is a platform for podcast listeners to discover podcast episodes based on other listeners reviews.

Electronic Communications

Visiting Hubl constitutes electronic communications. You consent to receive electronic communications and you agree that all agreements, notices, disclosures and other communications that we provide to you electronically, via email and on the Site, satisfy any legal requirement that such communications be in writing.

Children Under Thirteen

Hubl does not knowingly collect, either online or offline, personal information from persons under the age of thirteen. If you are under 18, you may use Hubl only with permission of a parent or guardian.

Links to Third Party Sites/Third Party Services

Hubl may contain links to other websites (“Linked Sites”). The Linked Sites are not under the control of FTLOP and FTLOP is not responsible for the contents of any Linked Site, including without limitation any link contained in a Linked Site, or any changes or updates to a Linked Site. Hubl is providing these links to you only as a convenience, and the inclusion of any link does not imply endorsement by Hubl of the site or any association with its operators.

Certain services made available via Hubl are delivered by third party sites and organizations. By using any product, service or functionality originating from the Hubl domain, you hereby acknowledge and consent that Hubl may share such information and data with any third party with whom FTLOP has a relationship to provide the requested product, service or functionality on behalf of Hubl users and customers.

No Unlawful or Prohibited Use/Intellectual Property

You are granted a non-exclusive, non-transferable, revocable license to access and use Hubl strictly in accordance with these terms of use. As a condition of your use of the Site, you warrant to FTLOP that you will not use the Site for any purpose that is unlawful or prohibited by these Terms. International Users

The Service is controlled, operated and administered by FTLOP from our offices within the USA. If you access the Service from a location outside the USA, you are responsible for compliance with all local laws. You agree that you will not use the FTLOP Content accessed through Hubl in any country or in any manner prohibited by any applicable laws, restrictions or regulations.

Indemnification

Arbitration

In the event the parties are not able to resolve any dispute between them arising out of or concerning these Terms and Conditions, or any provisions hereof, whether in contract, tort, or otherwise at law or in equity for damages or any other relief, then such dispute shall be resolved only by final and binding arbitration pursuant to the Federal Arbitration Act, conducted by a single neutral arbitrator and administered by the American Arbitration Association, or a similar arbitration service selected by the parties, in a location mutually agreed upon by the parties. The arbitrator's award shall be final, and judgment may be entered upon it in any court having jurisdiction. In the event that any legal or equitable action, proceeding or arbitration arises out of or concerns these Terms and Conditions, the prevailing party shall be entitled to recover its costs and reasonable attorney's fees. The parties agree to arbitrate all disputes and claims in regards to these Terms and Conditions or any disputes arising as a result of these Terms and Conditions, whether directly or indirectly, including Tort claims that are a result of these Terms and Conditions. The parties agree that the Federal Arbitration Act governs the interpretation and enforcement of this provision. The entire dispute, including the scope and enforceability of this arbitration provision shall be determined by the Arbitrator. This arbitration provision shall survive the termination of these Terms and Conditions.

Class Action Waiver

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING, SUCH

AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER. Further, unless both you and FTLOP agree otherwise, the arbitrator may not consolidate more than one person's claims, and may not otherwise preside over any form of a representative or class proceeding.
